

Diploma in Investment Operations



The Diploma in Investment Operations offers practitioners the opportunity to specialise in the administration of investment funds and custody and settlement.

Within the industry, it is widely acknowledged as the most appropriate higher level qualification for professionals wanting to pursue a career in investment operations.

How is the qualification structured?

The qualification is achieved by passing:

- ◇ Level 4 Operational Risk
(one hour, 50 multiple-choice question exam)
- ◇ Level 5 Managing Operational Risk in Financial Institutions
(1 hour 45 minutes, 70 multiple-choice question exam)

AND
Global Operations Management module

Studying for the DIO

- ◇ Candidates are advised to allocate approximately 220 hours for the Operational Risk and Managing Operational Risk in Financial Institutions and 200 hours for the Global Operations Management unit.
- ◇ The computer based testing is delivered at Computer Domain in Mosta or remotely.

Who should study this Qualification?

The Diploma in Investment Operations is a valuable qualification if you hold a supervisory level position and you are aspiring to a senior management role in investment operations.

Next steps:

Upon successful completion of the Diploma in Investment Operations you will have the opportunity to upgrade to full membership and you will be able to use the MCSI designatory letters.
